NATIONAL RES TARGETS FOR GREECE (2010)

• EU DIRECTIVE ON THE PROMOTION OF RES ELECTRICITY

- i) Indicative target for Greece, for the year 2010:
 - 20.1% of total electricity demand, or 14.5 TWh/year, to be covered by RES (including large hydro)
 - 14.5% of total electricity demand, or 10.5 TWh/year, to be covered by RES (excluding large hydro)

• REQUIRED RES-ELECTRICITY CAPACITY BY THE YEAR 2010

- i) Total RES-electricity capacity required: ~ 3500 MW_e (based on a RES-averaged capacity utilisation factor of 35%, or about 3000 hr/year)
- ii) Indicative capacity breakdown by RES type:
 - 2800 MW_e of wind parks
 - 400 MW_e of small hydro plants
 - 200 MW_e of biomass plants
 - 100 MW_e of other RES units





THE SOLUTION

Joint Ministerial Decision (JMD) No. 1726 (April 2003) for the simplification of the RES licensing procedures (for wind and small hydro plants)

- JMD 1726 is signed by the ministers of <u>all seven (7) Ministries</u> that are co-responsible for the RES licensing process, namely the Ministries of :
 - > National Economy
 - Development (Energy)
 - ➤ Environment, Land Planning & Public Works
 - > Agriculture
 - > Culture
 - > Transportation & Communications
 - National Defense

- JMD 1726 covers all three basic (and time consuming) stages of the RES licensing process :
 - > Preliminary environmental impact assessment
 - > Approval of environmental terms and conditions
 - > Approval of intervention on public land
- JMD 1726 defines clearly and unambiguously the specific public authorities, agencies and directorates that are required to give an opinion (or to make a decision) regarding the licensing of a RES project. Their total number is significantly reduced.

 JMD 1726 describes in detail the contents of the specific opinion, to be given by each one of the above authorities or agencies • JMD 1726 sets strict deadlines for the licensing authorities or agencies, within which they are required to give their opinions about the RES project under consideration. These deadlines are:

1. Preliminary environmental impact assessment : 30 working days (total)

2. Approval of environmental terms and conditions : 60 " " "

3. Approval of intervention on public land : 40 " " "

Total licensing time for RES projects: 90 working days (total)

 The above deadlines have an irrevocable character, i.e. beyond them, the respective authorities, agencies, committees, etc., that have not responded, are counted as having positive opinions (answers) towards the given RES project, and the licensing procedure moves on to the next stage.
